

SSS Event COVID-19 Disclaimer

The below disclaimer is applied to all SSS Events. By participating in SSS Events you agree to adhere to the following regulations:

- SSS will make every reasonable effort to ensure events are run in a safe environment. It is the responsibility of all SSS member institutions and their studentathletes to consider any medical conditions before entering or competing in a SSS event
- If you know or are aware of medical conditions that might interfere with you or anyone else from participating safely, please consult a medical professional before participating

In reference to COVID-19, it is also important to consider if you are deemed at risk or within a vulnerable category based on current government advice. It is the responsibility of all SSS members and their student-athletes to consider this and obtain an occupational health assessment if necessary.

If a member of your household gets symptoms of COVID-19 in the lead up to the event you must not attend.

All competitors will be required to fill out a COVID-19 health questionnaire before admittance to all SSS events and abide by all COVID-19 specific instructions detailed in the event entry information e.g. hand washing & Social distancing. We are putting extra measures in place regarding COVID-19 however it is impossible to fully remove all risk. By entering this event you:

• Have carefully considered your options and made sure you are completely comfortable with the risks associated with COVID-19.

It is in the interests of all event competitors to inspect the conditions of the competition area and it is entirely your decision to take part.

Please ensure you are fully conversant with the rules of the event. By entering the competition this acts as the argument that neither the organisers nor their agents, officials, volunteers, landowners, or fellow competitors shall be liable in any way from any damage or injury suffered by the individual in connection with this event.









All participants assume full responsibility for all injuries, losses, and damages that are incurred while participating in SSS events.

SSS will be monitoring and implementing all <u>sports-related</u> and <u>Scottish Government</u> guidance at all our events. All events will have a designated COVID officer present for the duration of the tournament.

SSS will not take any responsibility for how individuals travel to and from the event. In reference to COVID-19, participants should be following the guidelines outlined by the Scottish Government which can be found here.

By participating in the SSS event, you agree:

- to abide by the rules of the competition and any additional event instructions
- that you are participating entirely at your risk: that you will participate in a manner that is safe
- that any personal event equipment you will use will be in good working order and properly maintained
- to abide by the rules of the site; to accept that you will be liable for any damage caused (knowingly or otherwise)
- to behave in a manner that befits a national sporting event, and any misbehavior may result in disciplinary action

As part of the entry process, we collect mobile phone numbers to use in case of last-minute changes/ cancellations and to pass out key information. Your details will be kept for 21 days by SSS and if required be used for the NHS track and trace.

All Competitors, officials, and volunteers must have the Protect Scotland Application downloaded to their phone to effectively track and trace.

During the event, various filming, photography, and broadcasting may take place. By your presence at an event, you grant permission for your likeness and voice to be included in pictures and/or on film, and their advertising without compensation or credit.
